

Direction to: First UMC, 446 E. Camden Ave., Moorestown, NJ

From Route 38 East:

Take Rte. 38 East to the traffic light at the Moorestown Mall (Classic Chevrolet on the right). At the third traffic light after this intersection, turn left onto Pleasant Valley Avenue. (Cornerstone Bank at the right corner, Strawbridge Lake on the left). Follow Pleasant Valley through one traffic light (Kings Hwy) to dead-end on Camden Avenue. The church is on the left at the corner of Pleasant Valley and Camden Avenues.

From Route 38 West:

Take Rt. 38 East to the fifth traffic light at Pleasant Valley Avenue and turn right onto Pleasant Valley Avenue. (Strawbridge Lake on the right). Follow Pleasant Valley Avenue through one traffic light (Kings Hwy) to dead-end on Camden Avenue. The Church is on the left at the corner of Pleasant Valley and Camden Avenues.

From Route 73:

Take Route 73 North or South to the exit for Route 38 East and follow the directions for:

From Route 38 East.

From NJ Turnpike:

Get off at Exit 4. Bear right out of the toll plaza onto Rte.73 North. Proceed North on Rt. 73. Turn right at the first light (Fellowship Road). Continue on Fellowship Road until you get to the fourth light (just past NFL Films Building on right) and turn left on to Pleasant Valley Avenue. (Farmer's & Mechanics Bank on the left). Stay on Pleasant Valley Avenue and cross over 2 lights. (First light crosses over Route 38, second light crosses over Kings Hwy.) The church is on the left at the corner of Pleasant Valley and Camden Avenues, just past the second light.

From Route 295 North:

Get off at Exit 36B marked "Rte. 73 North - Tacony Bridge" directly onto Route 73 North. Proceed North on Rte. 73 through one traffic light. Take the right-hand exit off of Rte. 73 for Rte. 38 East marked "Rte. 38 East - Moorestown - Mt. Holly", then follow the directions for: ***From Route 38 East.***

From Route 295 South:

Get off at Exit 36B marked "To Route 73 North - Tacony Bridge" (also marked "shopping center"). Turn right at the first traffic light (at the end of the exit ramp) onto Nixon Drive. Follow this around the back of the Moorestown Mall. At the second traffic light, turn right onto Route 38 East. Proceed on Route 38 to the second traffic light and turn left onto Pleasant Valley Avenue. (Cornerstone Bank on right and Strawbridge Lake on left). Follow Pleasant Valley Avenue through one traffic light (Kings Hwy) to dead-end on Camden Avenue. The church is on the left at the corner of Pleasant Valley and Camden Avenues.
